

Time is computed from the time vehicle and helpers report at the original point of loading until the completion of unloading and packing the last load at final destination, less time spent for meals or vehicle breakdown, plus an added charge for each vehicle and all helpers used, to cover running time which shall not be assessed more than once during any one day to the same shipper for the same vehicle as stated below:

Based on the distance between the original point of loading and final point of unloading in accordance with odometer readings:

He/She may give a written estimate, but in doing so be qualified to estimate within twenty five (25%) of the actual charges. The final charges to be assessed shall be in accordance with actual tariff rates.
