Minutes

Welcome and introductions: Members were welcomed and introduced themselves.

Ad Hoc Committee Orientation presentation: TURA staff delivered a presentation introducing the purpose of the Ad Hoc Committee, and covered the schedule for committee activities

Discussion: A brief summary of the discussion following the orientation presentation follows.

 Members inquired about the availability of additional background information, including findings from TURA program evaluations and the timetable for the FY19 Governor's Report.

- TURA program will include relevant program evaluation information in background documents.
- FY19 Governor's Report will be ready by the AHC meeting on the topic of Fees.
- Members asked for clarification about scope of the AHC's responsibilities and shared items they hope will be included.
 - A member commented that there are additional issues MCTA would like to address.
 - A member expressed a desire for the AHC to engage with TUR Planners Association questions that had led to the 2006 amendments, concerning frequency of planning and whether resource conservation could be a suitable alternative when companies reach a brick wall.
 - A member asked about the implications for MA businesses of potential Defense Production Act invocation for the manufacture of PPE.
 - A member asked for clarification about what Dan Sieger meant by "proposals," and he replied that they would come out of the meetings and discussion.
- Dan Sieger invited members with specific topics, proposals, or concerns to communicate them to Tiffany Skogstrom, who is the point of contact for the AHC.
- A member asked whether meetings would include opportunities for small group discussion.
 - TURA staff responded that the format will depend on the topic and on levels of engagement with the discussion, and that hosts will be prepared to break out into small groups as needed.
