Wɔ nnansa yi nhiam ase no, EEC de amaneɛbɔ a ɛfa Abakɔsɛm Nhwehwɛmu (BRC) dwumadi a ebefi ase aye adwuma wɔ **August mfinimfini** too gua. Nea εbeγε na wɔadi ɔman mmara so no, nea εbeκa wei ho ne EEC a **wɔde ɔmantam no akyi nhwehwɛmu a wɔbeγε ho nhyehyɛ**

Nsakrae ahorow a ደዳ kwan mu yi ka adwumakuw no nnwuma mu nsakrae a ወርሃይ de adi dwuma pa ho. Wei nso ne ፀን botae a መኑ së ፀይይሱ ደውማዲ ne mmara wō adwumakuw no nyinaa mu de ahዥሮ mmofra bammር hyia.

Ebedu August awiei no, na wɔn a wɔrepe atenae ne gyinabea (R&P) no, na wɔatumí aye wɔn **abakɔsem mu nhwehwemú wɔ EEC Navigator adwinnade no so**, baabi a adwumayɛfo, sukufo ne mmusua mmofrahwɛ dwumadi nyinaa ye adwuma wɔ so no. Nsakrae yi bɛma wɔagyae EEC BRC Manager adwinnade a wɔde ye adwuma no.

Wɔ nnipa pii fam no, nea ebefi abakɔsem mu nhwehwemu no mu aba no bεba ntɛm, na ama wɔatumi afi adwuma ase ntɛm. Anye yie koraa no, bere a wɔatwa so yi betew ɔbre ne sikasem ho haw a saafo yi bεfa mu no so.

Mfaso a dwumadi foforo yi de bεba ne nsakrae a εbεba mu no bi ne:

- Edefa ɔmantam foforo mu nhwehwemu ho no, se nipa no atena ɔmantam foforo mu pen wɔ mfe 5 a atwam mu a, EEC bεre nsem efi saa amantam hɔ kyerewtohɔ a εfa mmofra ayayade ne nea εtete saa ho.
 - Se mantam foforo ammua EEC no nsem a wɔrepε no a, wɔbεtɔa so ahwε fata a onipa no fata mu.
 - Se EEC nsa ka mmuae fi ɔmantam foforo no hɔ bere a wɔasi wɔn gyinae awie na nsem no betumi ama onipa no mfata a, EEC bεsan ahwehwε onipa no kyerewtohɔ mu ahwε se ɔfata gyinabea a okura no anaa.
 - Wɔhwehwε se wobegye obiara **nsatiaa ahyensode(fingerprint) ansa na BRC nhwehwemu afoforo** no akɔ so [te se, CORI ne DCF/SORI]. Nsateaa ahyensode no rensan nnye adwuma wɔ BRC dwumadi no mu.
 - Afei de, wɔn nsa bεka email a εbεkyerε da a wɔbεyε wɔn fingerprint no, sen se wɔbεtwεn ama εho krataa aba wɔn adaka mu ansa. Wɔnam email so nkutoo na εde nsem yi bεmane, enti ehia se **obiara a ɔwɔ mu no nya n'ankasa email adres**.
 - Nsakrae yi kyere se worentumi mmfa ntεmpε tebea BRC ne adwumayεfo a wɔnam nsem tebea bi nti wɔafa wɔn no mmane bio. **Εse se wɔn a wɔrepε hokwan no du ahwehwεde no ho koraa ansa na wɔatumi de ɔhwε ama**. Bere rekɔ so no, EEC bεkɔ so ahwehwε nkɔso a wobetumi aye wɔ BRC dwumadi no mu.
 - Afei de, EEC bεhwehwε CORI ne DCF nhwehwemu nyinaa na wɔama ho kwan, na wei beyi adesoa a εdeda dwumadi ahorow so no.
 - Yεde ade baako to nkyεn a, wɔbεyε BRC dwumadi no nyinaa wɔ Navigator so. Wɔn a wɔcwɔ ho nkrataa nkutoo na wɔbεvε BRC wɔ LEAD so.

- LEAD de nkaebɔ bɛma wɔn a wɔcwɔ tumi krataa no bere a BRC a wɔbɛye no foforo reye aduru nna 120, 60, ne 30 ansa na da no aduru. Wɔ LEAD mu no, saafo yi betumi anya BRC foɔm a wɔde no pɛ ne hokwan foforo no efi bere a aka nna 120 rekɔ ansa na awu no.
- Wɔ Navigator mu no, tumi krataafo ne BRC adwumayɛfo a wɔapaw wɔn betumi ahwehwɛ adwumayɛfo a bere aso sɛ wɔyɛ wɔn nkrataa foforo na wɔde wɔn fingerprint agu BRC Manager adwinnade so dedaw ho amaneɛbɔ mu.
- Adwumayɛfo a wɔn fingerprint wɔ kyerɛwtohɔ mu dedaw no, εho renhia sɛ wɔtwe begu so na ama wɔakɔ so aye adwuma wɔ wɔn dwumadi mu bere a wɔrepɛ BRC hokwan no mu.
 - Ebia εho behia sɛ wɔtwe fingerprint sɛ odwumayeni bi te nka sɛ ɔwɔ fingerprint a edi mu wɔ kyerɛwtohɔ a ɛwɔ dwumadi foforo bi ase a. Edefa wɔn a ehia sɛ wɔtwe wɔn fingerprint fi baabi no, εsε sɛ wɔde wɔn ho nsɛm gu Navigator so ansa, na afei wɔne Nkitahodi Asoeɛ no di nkitaho. Yɛsre wo hye no nsow sɛ wɔn a wɔrepɛ hokwan no benya fingerprint email bere a wɔde wɔn ho nsɛm agu Navigator mu no, na εho nhia sɛ wɔyɛ biribiara wɔ wei ho.
 - **Wɔn a wɔcwɔ tumi krataa nkutoo na wobenya hokwan akɔ Navigator Dwumadi Adwinnade no mu.** Sɛ wopɛ sɛ woma afoforo saa hokwan yi a, εho behia sɛ wode wɔn BRC gu Navigator mu na afei wone Nkitahodi Asoeɛ no adi nkitaho (denam fon anaa tikiti so) na wɔatwe fingerprint afi baabi foforo sɛ odwumayeni no wɔ fingerprint a εyɛ adwuma dedaw a.

Nna a εho Hia:

- Wobegye Ntɛmpɛ BRC a etwa to no nnɔnhwerew 24 ansa na nsakrae biara aba adwinnade no mu, na saa bere no, EEC remma hokwanpɛfo kɔndihyinal stetɔs bio.
- EEC bɛma da pɔtee no wɔ bere tiawa mu.
