**CAZADORES RESTAURANTE MEXICANO LLC

Cazadores Restaurante Mexicano LLC ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 12. The Alcoholic Beverages Control Commission ("ABCC" or "Commission") held a hearing on Tuesday, September 30, 2025, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing, the Licensee stipulated to the facts alleged in Investigators Doyle and Quinn's Minimum Purchase Age Compliance Check Field Report.

The following documents are in evidence:

1. Investigators Doyle & Quinn's Minimum Purchase Age Compliance Check Field Report, 6/3/2025;
2. Licensee's Accela Workflow History, License Approved, 11/21/2016;
3. Licensee's Stipulation of Facts.

FINDINGS OF FACT


1. On Tuesday, June 3, 2025, at approximately 6:46 p.m., Investigators Doyle and Quinn ("Investigators"), conducted a compliance check of Cazadores Restaurante Mexicano LLC.
2. An underage operative, working under the supervision of Investigators, purchased an alcoholic beverage, one 12-ounce bottle of Bud Light beer, for six dollars and ninety-six cents (\$6.96). The underage operative was not asked for identification.
3. The Licensee has held a license under M.G.L. c. 138, § 12 since 2016.

CONCLUSION


Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. As a result, the Commission issues a WARNING.


