**DECISION**

**TREMONTE PIZZERIA LLC D/B/A TREMONTE PIZZERIA  
361 MIDDLESEX ROAD

Tremonte Pizzeria LLC d/b/a Tremonte Pizzeria (“Licensee”) holds an alcohol license issued pursuant to M.G.L. c. 138, § 12. The Alcoholic Beverages Control Commission (“Commission” or “ABCC”) held a hearing on Tuesday, September 23, 2025, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing the Licensee stipulated to the facts alleged in Investigators Doyle & Quinn’s Minimum Purchase Age Compliance Check Field Report.

The following documents are in evidence:

1. Investigators Doyle & Quinn’s Minimum Purchase Age Compliance Check Field Report;
2. ABCC Application Summary Review, Transfer of License Approved 10/19/2017;
3. Licensee Stipulation of Facts.

There is one (1) audio recording of this hearing.

**FINDINGS OF FACT**

1. On Tuesday, June 3, 2025, at approximately 5:32 p.m., Investigators Doyle & Quinn (“Investigators”) conducted a compliance check at Tremonte Pizzeria LLC d/b/a Tremonte Pizzeria.
2. An underage operative, working under the supervision of Investigators, was delivered an alcoholic beverage one Bud Light draft beer. The underage operative was not asked for identification.
3. The Licensee has held a license under M.G.L. c. 138, § 12 since 2017 with no previous violations.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Therefore, the Commission issues a WARNING.
