

AGENT/BROKER/SOLICITOR

Agent/Broker/Solicitor License

M.G.L. c. 138, §18A

A license to solicit orders from licensed wholesalers on behalf of licensed suppliers. *A broker may not buy or sell alcoholic beverages and may not bring alcoholic beverages into Massachusetts.*

Salesperson Permit

M.G.L. c. 138, §19A

A permit authorizing an individual employed by a licensed broker to solicit orders for alcoholic beverages from licensed wholesalers on behalf of that employer.

Salesperson of a Broker Transportation Permit

M.G.L. c. 138, §22

A permit authorizing the holder to pick-up alcoholic beverages lawfully obtained by the broker from a wholesaler in Massachusetts and deliver the same to another wholesaler in Massachusetts.

AIRLINE

Airline Sale to Passengers License

M.G.L. c. 138, §13

A license to sell alcoholic beverages for passenger consumption on an aircraft.

Airplane Cargo

M.G.L. c. 138, §22

A permit authorizing the holder to transport and deliver alcoholic beverages lawfully sold by a licensee in Massachusetts to a lawful buyer in Massachusetts.

CATERING

Caterer

M.G.L. c. 138, §22

A permit authorizing the holder to transport and deliver alcoholic beverages lawfully sold by an off-premises licensee in Massachusetts to a lawful consumer in Massachusetts. This permit does not authorize a caterer to purchase, sell or resell alcoholic beverages.

CERTIFICATE OF COMPLIANCE

Certificate of Compliance

M.G.L. c. 138, §18B

A permit authorizing an out of state licensee to export or sell alcoholic beverages to Massachusetts licensed wholesalers. *A certificate of compliance holder shall not sell directly to retailers.*

COMMERCIAL ALCOHOL LICENSE

Non-Beverage Use of Alcohol License

M.G.L. c. 138, §76

A license authorizing the manufacture, transport, import, export and sale of alcohol for mechanical, manufacturing or chemical purposes only or for sale to any wholesaler or manufacturer in Massachusetts or to any other buyers specified in state law.

CONSUMER RESEARCH

Consumer Research Special Permit
M.G.L. c. 138, §22A

A permit authorizing the holder to conduct consumer-tasting research with alcoholic beverages.

FARMER BREWERY

Farmer-Brewery License
M.G.L. c.138, §19C

A license authorizing producing malt beverages from the fermentation of malt with or without cereal grains or fermentable sugars, or of hops, provided that said hops or cereal grains are grown by the farmer-brewer and to sell at wholesale to licensed manufacturers, wholesalers, farmer-brewers, and licensed retailers in Massachusetts, at wholesale to other buyers specified in state law, and at retail by the bottle for consumption off the premises.

Farmer-Brewery Transportation Permit
M.G.L. c. 138, §22

A permit authorizing the holder to pick-up malt beverages lawfully bought by the licensee from a licensee in Massachusetts; also authorizes the delivery of malt beverages lawfully sold by the licensee to retailers and wholesalers in Massachusetts.

Salesperson Permit
M.G.L. c. 138, §19A

A permit authorizing an individual employed by a licensed farmer-brewery to solicit orders for malt beverages from licensed wholesalers (or retailers, as the case may be) on behalf of that employer.

Salesperson of a Farmer-Brewery Transportation Permit
M.G.L. c. 138, §22

A permit authorizing the delivery of limited quantities of malt beverages lawfully sold by the licensee to retailers and wholesalers in Massachusetts.

FARMER DISTILLERY

Farmer-Distillery License
M.G.L. c. 138, §19E

A license authorizing producing, manufacturing or distilling of distilled spirits by the person who grows fruits, flowers, herbs, vegetables, cereal grains or hops for the purpose of producing alcoholic beverages. A farmer-distillery may sell at wholesale to licensed farmer-distilleries, manufacturers, wholesalers, and licensed retailers in Massachusetts, at wholesale to other buyers specified in state law, and at retail by the bottle for consumption off the premises.

Farmer-Distillery Transportation Permit
M.G.L. c. 138, §22

A permit authorizing the holder to pick-up alcoholic beverages lawfully bought by the licensee from a licensee in Massachusetts; also authorizes the delivery of alcoholic beverages lawfully sold by the licensee to retailers and wholesalers in Massachusetts.

FARMER WINERY

Farmer-Winery License
M.G.L. c. 138, §19B

A license authorizing producing, rectifying, blending or fortifying wine from fruits, flowers, herbs or vegetables and sell to licensed wholesalers in Massachusetts, to persons in a state or territory in which the importation and sale of wine is not prohibited by law at retail or wholesale, and at wholesale to a person in any foreign country.

Farmer-Winery Transportation Permit
M.G.L. c. 138, §22

A permit authorizing the holder to pick-up wine lawfully bought by the licensee from licensee in Massachusetts; also authorizes the delivery of wine lawfully sold by the licensee to wholesalers in Massachusetts.

Winery Shipment License
M.G.L. c. 138, §19F

A license authorizing a premises where wine is produced, rectified, blended or fortified from fruits, flowers, herbs or vegetables, or where wine is bottled or packaged to sell and ship winery products produced by it at retail directly to consumers, at wholesale to licensed retailer and at wholesale to other buyers specified in state law.

Winery Shipment Transportation Permit
M.G.L. c. 138, §22

A permit authorizing the delivery of wine lawfully sold by the licensee to consumers in Massachusetts; also authorizes the delivery of wine lawfully sold by the licensee to retailers and wholesalers in Massachusetts.

Salesperson Permit
M.G.L. c. 138, §19A

A permit authorizing an individual employed by a licensed farmer-winery to solicit orders for wine from licensed wholesalers on behalf of that employer.

Salesperson of a Farmer-Winery Transportation Permit
M.G.L. c. 138, §22

A permit authorizing the delivery of limited quantities of wine lawfully sold by the licensee to wholesalers in Massachusetts.

GOING OUT-OF-BUSINESS SPECIAL PERMIT

Licensee Going-Out-Of-Business Special Permit
M.G.L. c. 138, §22A

A permit authorizing the license-holders, who have gone or are going out of business, to sell their existing inventory of malt beverages to other licensees in Massachusetts.

MANUFACTURER

Manufacturer of All Alcoholic Beverages License
M.G.L. c. 138, §19

A license authorizing the manufacturing, rectifying or blending of all kinds of alcoholic beverages and sale of those beverages manufactured, rectified or blended to other licensed manufacturers, wholesalers and retailers in Massachusetts.

Manufacturer of Wine and Malt Beverages License
M.G.L. c. 138, §19

A license authorizing the manufacturing or blending of wine and/ or malt beverages and sale of those beverages manufactured, or blended to other licensed manufacturers, wholesalers and retailers in Massachusetts.

Manufacturer's Transportation Permit
M.G.L. c. 138, §22

A permit authorizing the delivery of alcoholic beverages lawfully sold by the licensee to Massachusetts licensed retailers and wholesalers.

PUB BREWERY

Pub Brewery License
M.G.L. c. 138, §19D

A license authorizing production of malt beverages from the fermentation of malt with or without cereal grains or fermentable sugars, or of hops, and sold and where alcoholic beverages or wine or malt beverages only are authorized to be sold for consumption on the premises. A pub brewery may sell those malt beverages so manufactured by it at wholesale to licensed wholesalers in Massachusetts and at retail by the bottle for consumption off the premises.

Pub Brewery Transportation Permit
M.G.L. c. 138, §22

A permit authorizing the holder to pick-up alcoholic beverages lawfully bought by the licensee from a licensee in Massachusetts; also authorizes the delivery of alcoholic beverages lawfully sold by the licensee to wholesalers in Massachusetts.

Salesperson Permit
M.G.L. c. 138, §19A

A permit authorizing an individual employed by a licensed pub-brewery to solicit orders for malt beverages from licensed wholesalers on behalf of that employer.

Salesperson of a Pub-Brewery Transportation Permit
M.G.L. c. 138, §22

A permit authorizing the delivery of limited quantities of malt beverages lawfully sold by the licensee to wholesalers in Massachusetts.

RAILROAD

Railroad Sale to Passengers License
M.G.L. c. 138, §13

A license to sell alcoholic beverages for passenger consumption in a licensed railroad car.

Railroad Cargo
M.G.L. c. 138, §22

A permit authorizing the holder to transport and deliver alcoholic beverages lawfully sold by a licensee in Massachusetts to a lawful buyer in Massachusetts,

SALESMAN

Salesperson Permit
M.G.L. c. 138, §19A

A permit authorizing an individual employed by a licensed wholesaler, broker, farmer-winery, farmer-brewery, or pub-brewery to solicit orders for alcoholic beverages from licensed wholesalers (or retailers, as the case may be) on behalf of that employer.

Salesperson of a Wholesaler, Farmer-Winery,
Farmer-Brewery, Pub-Brewery Transportation Permit
M.G.L. c. 138, §22

A permit authorizing the delivery of limited quantities of alcoholic beverages lawfully sold by the licensee to wholesalers (or retailers, as the case may be) in Massachusetts.

SHIP

Ship Sale to Passengers License
M.G.L. c. 138, §13

A license to sell alcoholic beverages to passenger for consumption on a ship.

Ship Chandler license
M.G.L. c. 138, §13

A license authorizing a ship chandler to purchase alcoholic beverages for provisioning ship(s) in Massachusetts.

Ship Cargo
M.G.L. c. 138, §22

A permit authorizing the holder to transport and deliver alcoholic beverages lawfully sold by a licensee in Massachusetts to a lawful buyer in Massachusetts.

STORAGE

Permit to Store Alcoholic Beverages
M.G.L. c. 138, §20

A permit authorizing a wholesaler, a farmer-brewer, a farmer-winery, or a manufacturer to store alcoholic beverages it is authorized to produce, sell and deliver.

TRANSPORTATION

Off-premises Transportation Permit
M.G.L. c. 138, §22

A permit authorizing the holder to pick-up alcoholic beverages lawfully bought by the licensee in Massachusetts; also authorizes the delivery of alcoholic beverages lawfully sold by the licensee to consumers in Massachusetts.

On-premises Transportation Permit
M.G.L. c. 138, §22

A permit authorizing the holder to pick-up alcoholic beverages lawfully bought by the licensee in Massachusetts. *An on-premises licensee may not deliver outside the licensed premise to consumers in Massachusetts.*

General Express/Trucking
M.G.L. c. 138, §22

A permit authorizing the holder to transport and deliver alcoholic beverages lawfully sold by a licensee in Massachusetts to a lawful buyer in Massachusetts.

WAREHOUSE

Public Warehouse Permit
M.G.L. c. 138, §20A

A permit authorizing a licensed public warehouse to store alcoholic beverages lawfully possessed by the person seeking to warehouse those alcoholic beverages.

Bonded Warehouse Permit
M.G.L. c. 138, §20

A permit authorizing a wholesaler, a farmer-brewery, a farmer-winery, or a manufacturer to store alcoholic beverages in bond and transfer these beverages from bond to the purchaser's licensed premises.

WINERY SHIPMENT

Winery Shipment License
M.G.L. c. 138, §19F

A license authorizing a premises where wine is produced, rectified, blended or fortified from fruits, flowers, herbs or vegetables, or where wine is bottled or packaged to sell and ship winery products produced by it at retail directly to consumers, at wholesale to licensed retailer and at wholesale to other buyers specified in state law.

Winery Shipment Transportation Permit
M.G.L. c. 138, §22

A permit authorizing the delivery of wine lawfully sold by the licensee to consumers in Massachusetts; also authorizes the delivery of wine lawfully sold by the licensee to retailers and wholesalers in Massachusetts.

WHOLESALER

Wholesaler License For All Kinds of Alcoholic Beverages
M.G.L. c. 138, §18

A license to import, export, and sell all kinds of alcoholic beverages to licensed Massachusetts retailers and wholesalers.

Wholesaler License for Wine and Malt Beverages
M.G.L. c. 138, §18

A license to import, export, and sell wine and malt beverages to licensed Massachusetts retailers and wholesalers.

Wholesaler License for Sacramental Wine
M.G.L. c. 138, §18

A license to import, export, and sell sacramental wines to any regularly ordained priest, minister, rabbi or any church or religious society.

Wholesaler Transportation Permit
M.G.L. c. 138, §22

A permit authorizing the holder to pick-up alcoholic beverages lawfully bought by the licensee from licensed suppliers; also authorizes the delivery of alcoholic beverages lawfully sold by the licensee to a Massachusetts Licensed retailers and wholesalers.

Salesperson Permit
M.G.L. c. 138, §19A

A permit authorizing an individual employed by a licensed wholesaler to solicit orders for alcoholic beverages from licensed wholesalers (or retailers, as the case may be) on behalf of that employer.

Salesperson of a Wholesaler Transportation Permit
M.G.L. c. 138, §22

A permit authorizing the delivery of limited quantities of alcoholic beverages lawfully sold by the licensee to retailers and wholesalers in Massachusetts.

IMPORT HOUSEHOLD EFFECTS/GIFT SPECIAL PERMIT

Personal Importation Special Permit
M.G.L. c. 138, §22A

A permit authorizing individuals, who are at least twenty-one years of age, who are relocating to Massachusetts, to import any alcoholic beverages specified therein which are acquired otherwise than by purchase and are not intended for sale.
