Dear Supplier of Public Water:

Massachusetts Department of Environmental Protection (MassDEP) Drinking Water Program has been notified by the U.S. EPA that your public water system's sources were tested during U.S. EPA's third cycle (2013-2015) of the Unregulated Contaminant Monitoring Rule (UCMR3). Unlike the first and second UCMR cycles, this round of required monitoring was sensitive down to the lowest level that is analytically feasible. That means you will need to report more results during this round, even though these detections could be well below any published health advisory or guideline.

We want to take this opportunity to remind you of the reporting requirements associated with U.S. EPA's UCMR3 monitoring program.

What Is Included in the UCMR3 Reporting Requirements?

• Tier 3 Public Notification (PN):

- All water systems must notify customers about the availability of UCMR3 results no later than 12 months after the results are known, as specified in 310 CMR 22.16(7). For an example, see the Tier 3 PN Template for UCMR3 Special Notice available at: http://www.mass.gov/eea/agencies/massdep/water/drinking/water-systems-ops.html#24.
- All systems must submit a PN certification form to MassDEP within 10 days of issuing the Tier 3 PN. The form is available at: <u>http://www.mass.gov/eea/docs/dep/water/laws/i-thru-z/pncert.pdf</u>.

• Consumer Confidence Report (CCR):

You must include UCMR3 detection information in your CCR in accordance with 310 CMR 22.16A(4)(l).

The UCMR3 information you must include in your CCR includes:

- The average and range of detections from of the prior year's monitoring, along with any applicable federal health advisory or state guideline.
- A statement that explains why you are monitoring for unregulated contaminants.
- As a reference, see the attachment titled Reporting UCMR3 Contaminant in Your CCR, which includes examples of the required UCMR3 information.

What If Your System's UCMR3 Reporting Requirements Are Incomplete?

If you were not able to notify your customers according to the timeframes specified above, if possible please include the required UCMR3 information in your **upcoming 2014 CCR**. Your **2014 CCR** must be prepared and distributed to all customers by **July 1, 2015**. If this timeframe is not possible (e.g., if your CCR is already at the printer), please include the required UCMR3 information in your **upcoming 2015 CCR**. Your **2015 CCR** must be prepared and distributed to all customers by **July 1, 2015**.

How Do You Access Your UCMR3 Monitoring Data?

If your public water system <u>serves more than 10,000 people</u>, you may access your UCMR3 monitoring results by logging into the Central Data Exchange (CDX) and the Safe Drinking Water Accession and Review System (SDWARS) at: <u>https://cdx.epa.gov/CDX/Login</u>. You received information about logging onto SDWARS and obtaining your water system's UCMR3 results from U.S. EPA in your 2012 initial contact letter from U.S. EPA which announced your participation in the program. For questions regarding SDWARS or CDX, please contact the CDX Help Desk at 1-888-890-1995. You can also contact the U.S. EPA UCMR3 Contract Lab that performed testing for your water system to obtain results or to ask questions on the analysis.

<u>If your water system serves less than 10,000 people</u>, you should/will receive a copy of your monitoring results from the U.S. EPA. You can also contact the U.S. EPA UCMR3 Contract Lab that performed testing for your water system to obtain results or to ask questions on the analysis.

Please note: UCMR3 data is also available on the National Contaminant Occurrence Database (NCOD) at <u>http://water.epa.gov/lawsregs/rulesregs/sdwa/ucmr/data.cfm#ucmr2013</u>. U.S. EPA updates the NCOD approximately quarterly (last update 01/2015). This data can be obtained as a downloaded text file which can then be extracted (i.e., compressed) and converted into an Excel file for easier viewing and analysis (the file contains nationwide results).

Reporting UCMR Contaminants in Your CCR

Why do you need to report Unregulated Contaminants Monitoring Rule (UCMR) contaminants in your Consumer Confidence report (CCR)?

Community Public Water Suppliers are required by 310 CMR 22.16A
(4)(I) to report UCMR data in their CCR.

Your CCR must include data collected between January and December of the previous calendar year.

When are you required to report UCMR contaminants in your CCR?

- If your water system detects unregulated contaminants in the CCR reporting year you must report it.
- Reminder: You must deliver your CCR by July 1 of each year.

What are you required to report in your CCR?

- The average of the entire year's monitoring results,
- The range of the entire year's detections and
- An educational statement explaining your system's monitoring of unregulated contaminants, such as:

"Unregulated contaminants are those for which EPA has not established drinking water standards. The purpose of unregulated contaminant monitoring is to assist EPA in determining their occurrence in drinking water and whether future regulation is warranted."

What optional information should you include or keep on file to address typical consumer questions?

• MassDEP Office of Research and Standards Guidelines (ORSGs) for 1,1-dichloroethane, bromomethane and 1,4-dioxane, available at:

http://www.mass.gov/eea/agencies/massdep/water/drinking/standards/standards-and-guidelines-fordrinking-water-contaminants.html#MassachusettsDrinkingWaterGuidelines . You may include these ORSGs in a column titled "EPA's Draft Reference Concentration¹ or MassDEP's ORSG," as shown below or keep this information on file to respond to typical consumer questions.

You may include these reference concentrations in a column titled "EPA's Reference Concentration¹ or MassDEP's ORSG," as shown below or keep this information on file to respond to typical consumer questions.

How should you report the required monitoring and any optional data in your CCR?

¹Reference Concentration: These reference concentrations are based on publically-available health information in the following EPA Resources: 2012 Drinking Water Standards and Health Advisories, the Contaminant Candidate List (CCL) 3 Contaminant Information Sheets, the Human Health Benchmark for Pesticides (HHBPs) or the 2014 Preliminary Regulatory Determinations for Contaminants on CCL 3. Many of the contaminants are currently under regulatory review or development and are subject to change as new health assessments are completed. EPA notes that a reference concentration "does not represent an "action level" (EPA requires no particular action based simply on the fact that UCMR monitoring results exceed draft reference concentrations), nor should the draft reference concentration be interpreted as any indication of an Agency intent to establish a future drinking water regulation for the contaminant at this or any other level. Decisions as to whether or not to regulate the contaminant in drinking water will continue to be made following the Agency's Regulatory Determination process."

We want to take this opportunity to remind you of the reporting requirements associated with U.S. EPA's UCMR3 monitoring program.

What Is Included in the UCMR3 Reporting Requirements?

- **Tier 3 Public Notification (PN):**
 - All water systems must notify customers about the availability of UCMR3 results no later than 12 months after the results are known, as specified in 310 CMR 22.16(7). For an example, see the Tier 3 PN Template for UCMR3 Special Notice available at: http://www.mass.gov/eea/agencies/massdep/water/drinking/water-systems-ops.html#24. You may update and post this notice.
 - All systems must submit a PN certification form to MassDEP within 10 days of issuing the Tier 3 PN. The form is available at: <u>http://www.mass.gov/eea/docs/dep/water/laws/i-thru-z/pncert.pdf</u>.
- Consumer Confidence Report (CCR):
 - You do not need to produce a CCR but you are required to post any CCR MassDEP provides to your water system and complete and return the certification form provided to you by MassDEP to certify the Tier 3 public notice distribution requirements are met.

What If Your System's UCMR3 Reporting Requirements Are Incomplete?

If you have not completed and certified Tier 3 PN in accordance with the requirements above, the required UCMR3 information will be included in your upcoming 2014 CCR, as applicable. As noted above, MassDEP

will provide non-community water systems with a CCR for posting. Your system must review, sign and post the MassDEP provided CCR and complete and return the certification form to MassDEP within 30 days of receipt of the CCR and certification form.

How Do You Access Your UCMR3 Monitoring Data?

You should/will receive a copy of your monitoring results from the U.S. EPA. You can also contact the U.S. EPA UCMR3 Contract Lab that performed testing for your water system to obtain results or to ask questions on the analysis.
