FINAL DECISION

In accordance with the Adjudicatory Proceeding Rules at 310 CMR 1.01(14)(b), Bonnie Heiple, Commissioner of the Massachusetts Department of Environmental Protection (“MassDEP” or “the Department”), has designated me the Final Decision-Maker in this administrative appeal.¹

I have reviewed the attached Administrative Consent Order with Penalty and Notice of Noncompliance, Enforcement Document No. 00013516 (“the Consent Order”) signed on February 28, 2023 by Urszula Aseltine the Petitioner, and on March 6, 2023 by Michael J. Gorski, Regional Director of the Department’s Western Regional Office. The Department issues this Final Decision incorporating the Consent Order. The Petitioner is ordered to pay a civil administrative penalty of one thousand five hundred dollars (\$1,500) within thirty days of the date of this Final Decision in accordance with paragraphs 13 and 20 of the Consent Order. Under the terms of 310 CMR

1.01(8)(c), this administrative appeal is dismissed with the Parties waiving whatever rights they may have to further administrative review before the Department as well as any appeal to Court.
