On November 4, 2015 the U.S. Probation and Pretrial Services Office will be hosting a Community Resource Fair at the John J. Moakley U.S. District Courthouse located at 1 Courthouse Way in Boston, Massachusetts.

Each year approximately 500 inmates are released from the Federal Bureau of Prisons to the District of Massachusetts and commence a term of supervised release. As a result of changes by the United States Sentencing Commission to drug sentencing guidelines, a number of federal inmates will be released earlier than originally expected in 2015. On November 1, 2015 approximately 40 inmates will be released to the District of Massachusetts.


In an effort to assist the individuals released on November 1, 2015, and other individuals who will be released to the community in the coming months, our office is reaching out to our community partners to help us with this event. The format will be similar to a career/job fair with each agency having a designated table and the ability to provide resources. The fair will be located in the Jury Assembly Room and will commence with opening remarks by the Honorable Patti B. Saris, Chief U.S. District Judge for the District of Massachusetts. Participants will have the opportunity to obtain resources that will assist in their re-entry into the community. Our office is currently working on resources that will assist the individuals with transportation to and from the event.
