NAND CORP. D/B/A UXBRIDGE BEER AND WINE 158 NORTH MAIN STREET UXBRIDGE, MA 01569 LICENSE#: 00012-PK-1304

NAND Corp d/b/a Uxbridge Beer and Wine ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("ABCC" or "Commission") held a remote hearing via Microsoft Teams on Tuesday, November 14, 2023, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing the Licensee stipulated to the facts alleged in Investigators Kujawski and Gould's Minimum Purchase Age Compliance Check Field Report.

The following documents are in evidence:

- 1. Investigators Kujawski and Gould's Minimum Purchase Age Compliance Check Field Report, 6/12/2023;
- 2. Licensee's Stipulation of Facts;
- 3. ABCC Form 43, Transfer of License Approval, 10/4/2013.

FINDINGS OF FACT

- 1. On Monday, June 12, 2023, at approximately 6:12 p.m., Investigators Kujawski and Gould ("Investigators") conducted a compliance check at NAND Corp. d/b/a Uxbridge Beer and Wine.
- 2. An underage operative, working under the supervision of Investigators, purchased an alcoholic beverage, one 25 oz. Natural Light beer, for one dollar and seventy cents (\$1.70). The underage operative was not asked for identification.
- 3. The Licensee has held a license under M.G.L. c. 138, § 15 since 2013.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. As a result, the Commission issues a **WARNING.**
