For example, if a salaried employee typically works 40 hours each week and they transport individuals during their standard 40 hour schedule, this time is not eligible for Public Assistance. If the driver works an additional hour, on top of the 40 hour schedule, transporting individuals to the vaccination site, that one extra hour is eligible for Public Assistance. We are part of a 6 municipality health consortium that is hosting vaccinations, which are open to (based on guidelines) any resident or employee in the 6 communities.
