### **Contract Summary**

This contract is a **Total Tire Management Program** that has full service and drop-ship services of **New and Retreaded Tires** for the many and varied vehicles and wheeled equipment in use throughout the Commonwealth.

#### How to Use This Contract?

**For Department Owned vehicles:** If the vehicle is a Department **Owned** vehicle, the driver must follow their department's own procedure for providing a purchase order number and billing address to the vendor

at the time of the service. Departments should be billed directly by the vendor and are responsible for any payment and follow up necessary to complete the purchase transaction.

**For OVM Leased vehicle:** If the vehicle is a **Leased** OVM vehicle, before installation, the shop will call OVM (James Guerrier) for a 5 digit Work Authorization Number. Tire purchases will be billed through the Goodyear Corporate Account and will be paid by OVM directly.

# **Pricing and Purchase Options**

All awarded contractors on this contract are offering a percentage off the Manufacturers Dated Price List. There are related services that are offered on a specific price basis that is noted in the award category, by Contractor. You will find pricing for all Tires and Tubes New and Retread in COMMBUYS under the Vendor's items tab.

#### **OEM Tires**

All New Tires are of quality that is Class "A" current production tires of the latest design and construction. Class "A" tires are at least first line, first grade, and are of no lower quality than tires normally furnished in representative quantities as standard original equipment for automobiles, trucks, tractors and similar vehicles.

All Police Pursuit Tires are certified for law enforcement, which includes **H** and **V** speed rating certification.

#### **Retread Tires**

#### **Retreading Process**

All retreaders will be using the Bandag retread process which consists of the following steps:

- 1) on site visual inspection
- 2) conditioning of casings
- 3) inspection and casing grading (includes x-ray, electronic and/or ultra-sonic inspection)
- 4) casing repairing
- 5) buffing
- 6) cementing
- 7) tread rubber application
- 8) curing
- 9) trimming and finishing
- 10) final inspection

#### **Retread Tire Standards**

All tires retreaded under this contract are processed in compliance with the latest edition of the industry standards "Retread Requirements Manual CTQP-441" which were developed jointly by the Federal Government, tire retreading associations and retread tire manufacturers. Additionally, all retread tires comply with the U.S. Department of Transportation Federal Motor Vehicle Safety Standards, which are the exact same standards used for new tires (D.O.T. FMVSS No. 109 New Pneumatic Tires and 119 New Pneumatic Tires for Vehicles Other Than Passenger Cars).

#### Retread Tire Warranty

All Contractors have provided a written warranty for workmanship and materials failure of the retread produced by the manufacturer or any subcontractor. Any failure in casings, treads or any repair portions of a tire due to conditions related to workmanship or materials, under terms of this warranty, shall be credited at a prorated level, based upon the amount of tread remaining. Copies of each manufacturer warranty are available from the manufacturer.

#### Pick-up/Delivery

Contractors have agreed to pick up worn tires on a regular basis or upon request as determined by the customer. Pick up will occur no later than three business days following the request. Contractors guarantee to complete the repair and retread process and deliver the tires back to the customer no later than seven business days after the pick-up. All casings will be inspected at the time of pick-up and delivery in the presence of a representative from the Purchasing Department. Should a casing be visually identified as non-retreadable, the Purchasing Department shall be informed prior to the collection of said tire. Vendors have agreed that if it is determined at the retread facility that a casing in not retreadable, the Purchasing Department will be provided with a Returned as Received (RAR) report, and will be charged for the disposal of the tire.

#### **Retreading Options**

Departments may elect to have their own casings retreaded at the prices listed in the cost tables. Alternatively, Departments may elect to purchase a retread tire on a casing provided by the retreader, in which case the cost of the tire will be higher than if the Department provides its own casing, however, this price will still be less than the cost of a new tire. Departments may also send a retreadable casing to the retreader without purchasing any retread tires and obtain a credit toward future purchases of retread tires.

#### **Additional Services**

Contractors provide a number of tire related services. These include tire mount/dismount, spin balance, computer balance, valve install, and pick-up and disposal of **small** quantities of tires (please, see cost tables for detailed cost information). To assist customers in tire management, contractors also offer:

- training programs related to retreading and tire maintenance practices
- fleet surveys
- tire evaluation comparisons
- fleet performance studies
- fleet maintenance and remedial action recommendations based on the above-mentioned studies

#### Tire Disposal

Contractors will provide the collection and proper disposal of scrap tires for the fees outlined in the cost tables. Please note that the purpose of this contract is **not** to provide tire disposal services for large numbers of tires or tire pile cleanup services. Use the Scrap Tire Disposal Services contract, VEH77A, if those services are needed.

Minimum Order: There is no minimum order.

#### **Delivery**

Delivery **must** be F.O.B. Destination with no delivery expenses paid by users of this contract. F.O.B. destination shall mean inside delivery to the ordering entity.

- The Contractor **must** contact the Eligible Entity at least 48 hours in advance of shipment to confirm the time and terms of delivery. The Contractor **may not** proceed with delivery until approval has been given by the ordering customer.
- All deliveries shall be performed during regular working hours, usually 8:00 a.m. to 5:00 p.m. Monday through Friday. Changes may be granted with written approval of the ordering entity.
- All deliveries **must** be made within forty-eight (48) hours of the order placement, or per a delivery schedule mutually agreed upon by the receiving entity and the Contractor.
- The Contractor **must** be responsible for the delivery of products in first class condition at the point of delivery, and in accordance with good commercial practice. Shipping cases **must** show the name of the supplier, name and address of receiving customer and Purchase Order number.
- Damaged shipments will not be accepted. In the event that a shipment is accepted and subsequently
  found to be incomplete, incorrect, or damaged, the shipment must either be replaced, at no cost to the
  receiving entity, or returned at the expense of the Contractor, for a refund or credit of the purchase
  price.
- Upon delivery, all retread tires shall be inspected by the customer for compliance with tread depth, contour and tread design specifications. Tires found to be defective will be returned to Contractor and reworked free of charge.
- If a casing sent for retreading cannot be processed, Contractors will provide Commonwealth customers with a written Returned as Received (RAR) report outlining all pertinent information as to why the casing cannot be accepted for retreading.
