C. Removal of Mercury-Added Switches and Components Before Crushing

If any vehicles were crushed, partially crushed, or baled by your own or hired mobile crushing unit at your business during this reporting year, then ALL required mercury-added switches and components (HID lamps) **must be removed** before the vehicles were crushed during the reporting year [310 CMR 74.04 (1) and (2)]. Resale of removed mercury switches and other mercury-containing devices are prohibited under 310 CMR 74.05.

D. Certification to Scrap Recycling Facilities

If your facility sold or delivered any crushed, partially crushed, flattened or baled vehicle bodies to a scrap recycling facility in Massachusetts during this reporting year, then you must certify in writing to scrap recycling facilities, for all crushed, flattened or baled vehicle bodies in each shipment sold or delivered to a scrap recycling facility, that all mercury-added switches and components were removed [310 CMR 74.04(3)]. You must retain a copy of the Scrap Recycling Facilities Certification in your records (See Section F of this form).

E. Management of Mercury-Added Switches and Components

All containers used to store mercury-added switches and components that were removed from vehicles **must be labeled and dated** (the date in which you started to store mercury-added switches and components [310 CMR 30.1034(7)(c)]), **in one of the following ways** [310 CMR 30.1034(4)(d)]:

- Universal Waste: Mercury-Containing Switches and Components
- Waste Mercury-Containing Switches and Components
- Used Mercury-Containing Switches and Components

Once mercury-added switches and components started being collected in a container, they must be shipped off-site to a facility licensed to handle mercury [310 CMR 30.1037(1)], within one year of the date in which you started storing the items [310 CMR 30.1034(7)(b)].
