## FY24 Vessel Tracking Requirement

As a federal lobster trap permit holder, you are required to install an Atlantic States Marine Fisheries Commission (ASMFC) approved vessel tracking device onboard the above vessel in accordance with Addendum XXIX to Amendment 3 to the American Lobster Fishery Management Plan. This Addendum delegated program administration to the state listed as the principal landing state on your federal permit, thus the Massachusetts Division of Marine Fisheries (MADMF) is tasked with administering your vessel's tracker. MADMF requires that vessels under its administration install and activate an approved tracking device prior to any fishing trip using trap gear occurring on or after May 1, 2023 (322 CMR 7.11). Once installed, the device must remain powered and transmitting data regardless of location, trip type, gear type, activity, or target species.

Additionally, each active federal trap permit holder with a Massachusetts principal port is eligible to receive a one-time payment of \$1,500 to offset the costs of this device and the associated service plan. Federal trap permit holders in LMA 6 are exempt from this requirement and ineligible for reimbursement. ASMFC and MADMF approved four tracking devices to date. Permit holders who will fish trap gear in federal fishing year 2024 (FY24) must contact an approved device vendor (see table below) and purchase an approved tracking device and service plan. Vessels with federal Vessel Monitoring Systems (VMS) must use an ASMFC approved tracker in addition to their federal VMS unit. Upon installation of the approved unit, you must complete an affidavit that certifies you are fulfilling your tracker requirements. If you will not fish traps in FY24, you are exempt from installing a tracker, and are ineligible for reimbursement but must still return the affidavit.

### FEDERAL AMERICAN LOBSTER COMMERCIAL TRAP GEAR AREA PERMIT HOLDERS VESSEL TRACKING AFFIDAVIT

Under the authority of the Atlantic Coastal Fisheries Cooperative Management Act, Addendum XXIX to Amendment 3 to the Interstate Fishery Management Plan for American Lobster and Addendum IV to the Fishery Management Plan for Jonah crab requires all vessels with a federal American Lobster Trap Gear Area permit to have an approved vessel tracker installed. Tracking devices must be installed prior to the permit holder's first fishing trip. <u>This vessel tracker must remain powered and transmitting when the vessel is in the water regardless of landing state, trip type, location fished, or target species.</u> All devices must follow the specifications outlined in Section 3.1 of Addendum XXIX.

The principal port on your Federal Fishery Permit lies within Massachusetts, thus the Massachusetts Division of Marine Fisheries (MADMF) will be tasked with certifying the installation of your vessel tracking device. *This requirement began in Massachusetts on May 1<sup>st</sup>, 2023 per 322 CMR 7.11.* In the event you believe your tracker is not functioning correctly and must be serviced or if the tracker must be powered down for vessel repairs, please contact MADMF at 978-491-6265 or email DMF.TRACKING@Mass.gov, and inform them of your situation.
