### Meeting Called to Order at 9:41 AM

#### **Board Business**

• The Board discussed the February 10<sup>th</sup> public meeting minutes. The Board confirmed that once the Board votes to approve meeting minutes, there will be no changes, and the Board Chair will sign the approved minutes. After further discussion, the Board tabled approval of the February meeting minutes in order to add additional information consistent with the Board's discussion of the February correspondences on administration of rabies vaccinations and controlled substances.

# **Executive Director Report, Including**

- The Executive Director asked the Board Members for their preference on how they would like to receive documents in preparation for meetings. Board Members confirmed they would like documents to be received in a PDF format.
- The Executive Director provided an update on the current veterinary renewals. The Executive Director and Board thanked Jen Fraga for all her work during the February annual renewal period.
- The Executive Director provided an update that the Division of Occupational Licensure is in the process of continuing to move towards the use of electronic records as well as moving paper records into storage.

- The Board discussed an email to the Board, dated February 4, 2022, from Margaret Gabour about medical records for herds. The Board stated that medical records for herds of animals can be maintained in a single record, and it is within the veterinarian's discretion to maintain the record in that manner. The Board further stated that the Board's regulation outlines what must be included in a medical record and that any medical issue or problem which arises with an animal within the herd must be documented in the medical record. Board staff to work with Board counsel to respond.
- The Board requested that the February 10, 2022 correspondence received from the International Council for Veterinary Assessment for nominations for its Assessment Development Committee be forwarded to Massachusetts Veterinary Medical Association.

#### **Discussion**

• The Board continued its discussion of the Board's draft Telemedicine Policy. After discussion, Dr. Orlowski motioned to approve the draft Telemedicine Policy, seconded by Dr. Patti. The motion passed by a roll call vote of 4-1. Members in favor: Dr. Kube, Dr. Patti, Dr. Diamond, and Dr. Orlowski. Members opposed: Dr. Sloane.
