## Public Meeting Minutes Thursday October 14, 2023

Board members and staff appeared by video conference.

The meeting was called to order by the chair at 9:35 A.M.

#### 1) Review Minutes of the meeting of September 14, 2023

Dr. Sloane made a motion, seconded by Dr. Orlowski, to approve the September public session minutes. The motion passed unanimously.

#### 2) Executive Director Administrative Report

- The Executive Director indicated that he is currently working with Counsel to prepare the institutional license renewal form for implementation in the next renewal period.

#### 3) Legal Counsel Report

- Counsel concurred with the Executive Director and added that she is also still working on the Board's regulations as well as developing the policy as directed by the Board on MCSR and DEA licenses.
- 4) **Reviewed and Discussed** Board Policy 13-02 and its relevance after new regulations regarding CE requirements in 256 CMR 9.00
  - The Executive Director and Board Counsel explained that the policy contains language that
    conflicts with the Board's current regulation which requires that continuing education must be
    completed in the calendar year prior to license renewal.

 After a brief discussion, the Board asked that the policy be amended to reflect the current regulation requirements for continuing education. A draft updated policy will be provided for review at the next Board meeting.

## 5) Correspondence

- Vet Tech Scope of Practice
  - After discussion, the Board directed the correspondent to the definition of the practice of veterinary medicine and stated that work by a veterinary technician needs to be supervised by a veterinarian.
- Pharmacy question
  - -After discussion, the Board directed the correspondent to DPH and DEA.

### 6) Matters not reasonably anticipated 48 hours in advance of the meeting.

- The Executive Director notified the Board that the topic of the 2024 Board meeting schedule will be added to the November agenda.
- The members briefly discussed how they would like to hold the remaining 2023 Board meetings.
   They agreed to hold the November and December 2023 meetings in a hybrid format allowing for remote and live attendance.
- 7) Quasi-Judicial Session to discuss disciplinary decisions (M.G.L. c. 30A, §18 Closed session)
  At 9:56 A.M., Dr. Orlowski made a motion, seconded by Dr. Tubman to exit the open session and enter closed quasi-judicial session to discuss disciplinary decisions. The motion passed unanimously.
- 8) Investigative Conference (M.G.L. c. 112, § 65C Closed session)

At 10:34 A.M., the Board voted to exit closed quasi-judicial session and enter closed Investigative Conference pursuant to G.L. c. 112, § 65C.
