DECISION

OM SAINATH INC. D/B/A CHOICE FOODS 2 MAIN STREET WALES, MA 01081 LICENSE#: 90977-PK-1312

Om Sainath Inc. d/b/a Choice Foods ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("Commission" or "ABCC") held a hearing on Tuesday, August 12, 2025, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing the Licensee stipulated to the facts alleged in Investigators Temple and David's Minimum Purchase Age Compliance Check Field Report.

The following documents are in evidence:

- 1. Investigators Temple and David's Minimum Purchase Age Compliance Check Field Report, 5/20/2025;
- 2. ABCC Licensing Authority Certification, New License Approved 3/12/2025;
- 3. Licensee's Stipulation of Facts.

FINDINGS OF FACT

- 1. On Tuesday, May 20, 2025, at approximately 7:12 p.m., Investigators Temple and David ("Investigators") conducted a compliance check at Om Sainath Inc. d/b/a Choice Foods.
- 2. An underage operative, working under the supervision of Investigators, purchased an alcoholic beverage, one 25-ounce Bud Light beer for three dollars and fifty-five cents (\$3.55). The underage operative was not asked for identification.
- 3. The Licensee has held a license under M.G.L. c. 138, § 15 since March 12, 2025.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. As a result, the Commission SUSPENDS the license for a period of one (1) day which will be held in abeyance for a period of two (2) years provided no further violations of Chapter 138 or Commission Regulations are found by this Commission.
