## FINAL DECISION

In accordance with her authority under the Adjudicatory Proceeding Rules at 310 CMR 1.01(14)(b), Bonnie Heiple, Commissioner of the Massachusetts Department of Environmental Protection ("MassDEP" or "the Department"), has designated me the Final Decision-Maker in this administrative appeal.<sup>1</sup>

I adopt the Recommended Final Decision of the Presiding Officer and Dismiss this appeal without prejudice pursuant to MassDEP Policy 88-3, Multiple Notice of Intent Filings for the Same or Similar Projects on the Same Property ("Policy 88-3"). As noted by the Presiding Officer on p. 2 of her Recommended Final Decision, in its October 27, 2023 filing in this appeal, the Petitioner agrees with the Presiding Officer that this appeal should be dismissed without prejudice pursuant to Policy 88-3. The Petitioner's agreement constitutes the Petitioner's voluntary withdrawal of this
