**BRUSO LIQUOR MART, INC.
144-46 MAIN STREET

Bruso Liquor Mart, Inc. (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("Commission" or "ABCC") held a hearing on Tuesday, September 17, 2019, regarding an alleged violation of 204 CMR 2.05 (2)-Permitting an illegality on the licensed premises, to wit: M.G.L. Ch.138 § 34- Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing, the Licensee stipulated to the facts alleged in Investigator Watson's Report.

The following documents are in evidence:

1. Investigator Watson's Compliance Check Field Report;
2. Licensee Stipulation of Fact;
3. Receipt for Alcohol Purchase;
4. Copy of Application Approved 7/16/1991;
5. ABCC Decision, 5/5/2009; and
6. ABCC Decision, 2/2/2005.

There is one (1) audio recording of this hearing.

FACTS

1. On Sunday, July 7, 2019, at approximately 5:44 p.m., Investigators Temple and Watson ("Investigators") investigated the business of Bruso Liquor Mart, Inc.
2. An underage operative, working with Investigators, purchased from the Licensee an alcoholic beverage, a bottle of Bud Light beer for three dollars (\$3.00). The underage operative was not asked for identification.
3. The Licensee has held a license under M.G.L. c. 138, § 15 since 1991.

CONCLUSION


Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2)- Permitting an illegality on the licensed premises, to wit: M.G.L. Ch.138 § 34- Sale or delivery of an alcoholic beverage to a person under twenty-one (21). The Commission issues a **WARNING**.
