## **DECISION**

ONSET VILLAGE MARKET INC. 231 ONSET AVENUE WAREHAM, MA 02558 LICENSE#: 1328-00042

VIOLATION DATE: 4/07/2018 HEARING DATE: 5/29/2018

Onset Village Market Inc. (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, May 29, 2018, regarding an alleged violation of 204 CMR 2.05 (2) — Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, § 34 — Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing, the Licensee stipulated to the violation alleged in Investigator Velez's Report.

The following documents are in evidence:

- 1. Investigator Velez's Compliance Check Field Report; and
- 2. Licensee's Stipulation of Facts;

There is one (1) audio recording of this hearing.

The Commission took Administrative Notice of the Licensee's record.

# **FACTS**

- 1. On Saturday, April 7, 2018, at approximately 3:45 p.m., Investigators Binienda and Velez ("Investigators") investigated the business of Onset Village Market Inc.
- 2. An underage operative, working with Investigators, purchased from the Licensee an alcoholic beverage, a 6-pack of Bud Light beer, for seven dollars and fifty cents (\$7.50). The underage operative was not asked for identification.

# CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, § 34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. As the Licensee has been in business for more than 10 years with no prior violations, the Commission issues a **WARNING**.
