DECISION

GLENDA'S ENTERPRISES LLC D/B/A GLENDA'S PUB 948 MAIN STREET WARREN, MA 01083 LICENSE#: 03020-RS-1330

VIOLATION DATE: 4/25/2023

HEARD: 9/19/2023

Glenda's Enterprises LLC d/b/a Glenda's Pub ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 12. The Alcoholic Beverages Control Commission ("ABCC" or "Commission") held a remote hearing via Microsoft Teams on Tuesday, September 19, 2023, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing the Licensee stipulated to the facts alleged in Investigators Guarino and Fleming's Minimum Purchase Age Compliance Check Field Report.

The following documents are in evidence:

- 1. Investigators Guarino and Fleming's Minimum Purchase Age Compliance Check Field Report, 4/25/2023;
- 2. Licensee's Accela Summary, Transfer of License Approved, 1/17/2017;
- 3. Licensee's Stipulation of Facts.
- A. TIPS Certificate of Completion for Karen Berthiaume;
- B. Licensee's Safety and Security Plan and Policy on the Sale and Service of Alcoholic Beverages.

FINDINGS OF FACT

- 1. On Tuesday, April 25, 2023, at approximately 7:10 p.m., Investigators Fleming and Guarino ("Investigators") conducted a compliance check at Glenda's Enterprises LLC d/b/a Glenda's.
- 2. An underage operative, working under the supervision of Investigators, purchased an alcoholic beverage, a bottle of Bud Light beer, for three dollars and fifty cents (\$3.50). The underage operative was not asked for identification.

- 3. Robert Madigan, Glenda Morin and Karen Berthiaume, Managing Members of the Licensee entity and the only Licensee employees, appeared at the Commission hearing. Ms. Morin is also the Manager of Record.
- 4. The Commission was informed that Ms. Berthiaume has since been re-certified via TIPS training. In addition, the Licensee has instituted a policy wherein all patrons who appear to be under the age of 40 are required to produce identification.
- 5. The Licensee has held a license under M.G.L. c. 138, § 12 since 2017 with no prior violations.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. As a result, the Commission issues a **WARNING.**
