DECISION

SHIVRAJAN INC. D/B/A WARREN PACKAGE STORE 942 MAIN STREET WARREN, MA 01083

LICENSE#: 89290-PK-1330 VIOLATION DATE: 4/25/2023

HEARD: 9/19/2023

Shivrajan Inc. d/b/a Warren Package Store ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("ABCC" or "Commission") held a remote hearing via Microsoft Teams on Tuesday, September 19, 2023, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing the Licensee stipulated to the facts alleged in Investigators Guarino and Fleming's Minimum Purchase Age Compliance Check Field Report.

- 2. ABCC Application Summary Review, Transfer of License Approved, 3/30/2018;

FINDINGS OF FACT

- 1. On Tuesday, April 25, 2023, at approximately 7:18 p.m., Investigators Fleming and Guarino ("Investigators") conducted a compliance check at Shivrajan Inc. d/b/a Warren Package Store.
- 2. An underage operative, working under the supervision of Investigators, purchased an alcoholic beverage, a 16-ounce bottle of Modelo beer, for three dollars and eighty-nine cents (\$3.89). The underage operative was not asked for identification.
- 3. The Licensee has held a license under M.G.L. c. 138, § 15 since 2018 with one prior violation.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. As a result, the Commission issues a **WARNING.**
