**SHIVRAJAN INC. D/B/A WARREN PACKAGE STORE
942 MAIN STREET

Shivrajan Inc. d/b/a Warren Package Store (“Licensee”) holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission (“ABCC” or “Commission”) held a remote hearing via Microsoft Teams on Tuesday, September 19, 2023, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing the Licensee stipulated to the facts alleged in Investigators Guarino and Fleming’s Minimum Purchase Age Compliance Check Field Report.

2. ABCC Application Summary Review, Transfer of License Approved, 3/30/2018;


FINDINGS OF FACT

1. On Tuesday, April 25, 2023, at approximately 7:18 p.m., Investigators Fleming and Guarino (“Investigators”) conducted a compliance check at Shivrajan Inc. d/b/a Warren Package Store.
2. An underage operative, working under the supervision of Investigators, purchased an alcoholic beverage, a 16-ounce bottle of Modelo beer, for three dollars and eighty-nine cents (\$3.89). The underage operative was not asked for identification.
3. The Licensee has held a license under M.G.L. c. 138, § 15 since 2018 with one prior violation.


CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. As a result, the Commission issues a **WARNING**.
