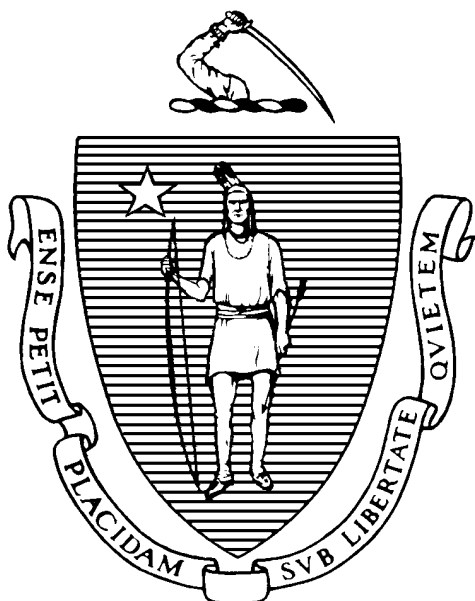

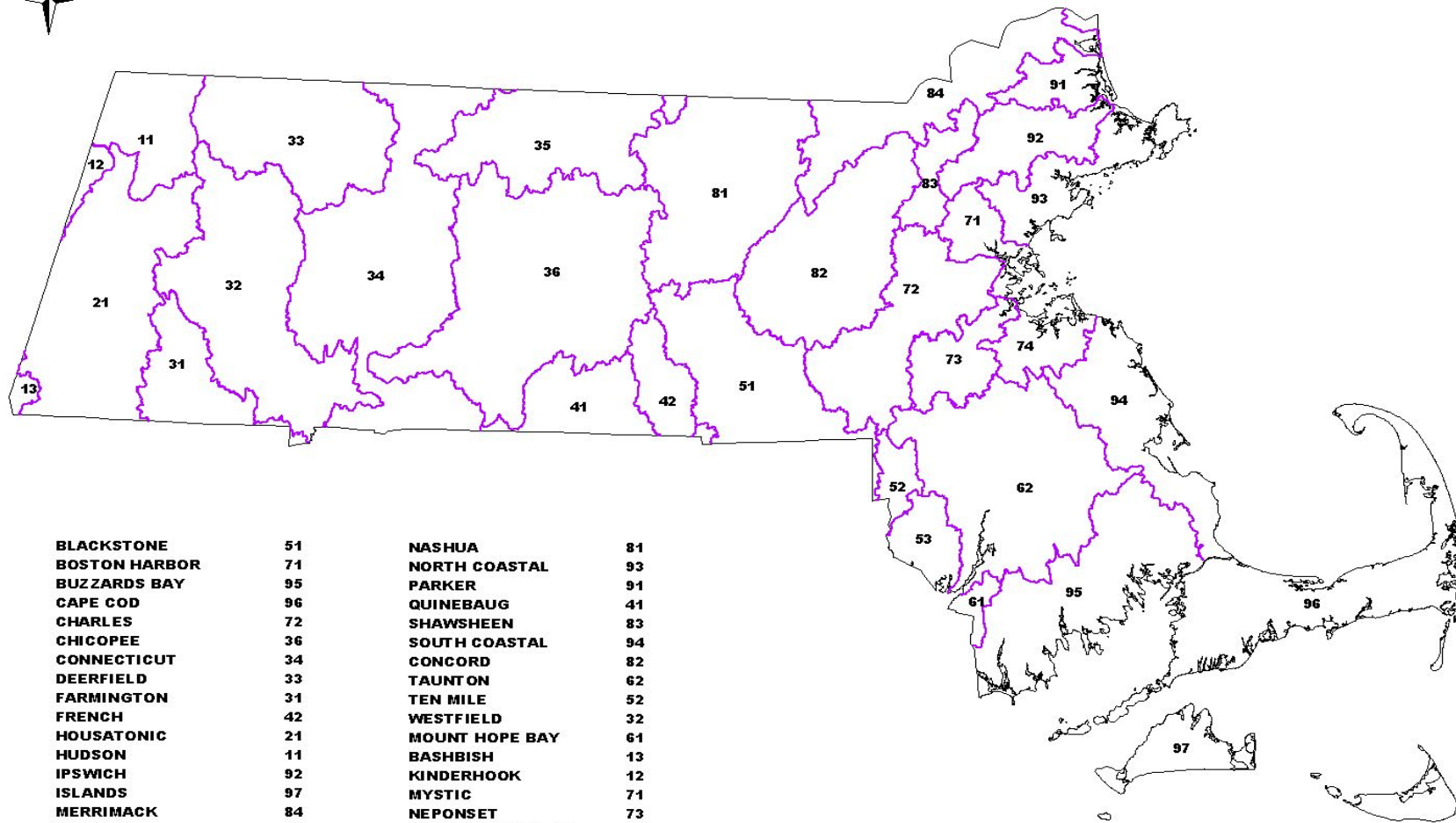

ABSTRACT

An index of technical reports and memoranda published by the Watershed Planning Program of the Massachusetts Division of Watershed Management during the fiscal years 1963-2009 has been compiled. Each report is catalogued chronologically by content and river basin. Reports are further referenced by specific subject categories pertaining to water quality survey data, wastewater discharge survey data, water quality analysis, water quality management plans, lake and pond studies, total maximum daily load analysis, current standard operating procedures, quality assurance project plans, and miscellaneous technical memoranda and reports.

New additions or updates to the 1963-2009 publications listing (from the 2008 version) are noted in **bold blue** type.

The complete list of reports published since 1963 is updated annually. I. INTRODUCTION

This report contains an index of selected published documents and technical memoranda prepared by the Watershed Planning Program of the Massachusetts Division of Watershed Management (DWM) during the Commonwealth's Fiscal Years 1963-2009.

The intent of this report is to provide a bibliographic index of scientific and technical publications for use by lake and watershed associations, regional planning agencies, cities and towns, and others seeking data relating to the chemical and biological quality of the Commonwealth's water resources.

Each report contained herein has been catalogued chronologically by subject matter and river basin in accordance with DWM's resource assessment and management programs.

Several specific categories of reports are recognized. Each publication is indexed according to the following scheme or combinations thereof:

- A** Water Quality Survey Data (physical, chemical and biological data compilation)
- B** Wastewater Discharge Survey Data (data compilation)
- C** Water Quality Analysis (data summary and interpretation)
- D** Water Quality Management Plans (planning, regulatory)
- E** Baseline and Intensive Lake and Pond Studies (data summary and interpretation)
- TMDL** Total Maximum Daily Load Analysis (data summary and interpretation)
- MS** Miscellaneous Statewide (including data and program summaries, quality assurance project plans and standard operating procedures (only current SOPs listed))
- MR** Miscellaneous Regional (site-specific, regional studies)
- TM** Miscellaneous Technical Memoranda (unpublished or published macroinvertebrate, fish and other data, quality control/data validation reports)

DWM internal document control numbers (CN) are also provided for specific documents where applicable. Only current, primary standard operating procedure (SOP) documents are listed. Previously used versions of SOPs are kept on file.

New additions or updates to the 1963-2009 publications listing (from the 2008 version) are noted in **bold blue** type.
