DECISION

LAVINS, INC. OF WAYLAND 330 OLD CONNECTICUT PATH WAYLAND, MA 01778 LICENSE#: 00015-PK-1340

VIOLATION DATE: 3/27/2024

HEARD: 7/30/2024

Lavins, Inc. of Wayland ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("ABCC" or "Commission") held a remote hearing via Microsoft Teams on Tuesday, July 30, 2024, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing, the Licensee stipulated to the facts alleged in Investigators Cutter & Teehan's Minimum Purchase Age Compliance Check Field Report.

The following documents are in evidence:

- 1. Investigators Cutter & Teehan's Minimum Purchase Age Compliance Check Field Report, 3/27/2024;
- 2. ABCC Form 43, New License Approval, 12/2/1963;
- 3. Licensee's Stipulation of Facts.

There is one (1) audio recording of this hearing.

FINDINGS OF FACT

- 1. On Wednesday, March 27, 2024, at approximately 6:39 p.m., Investigators Cutter and Teehan ("Investigators"), conducted a compliance check at Lavins, Inc. of Wayland.
- 2. An underage operative, working under the supervision of Investigators, purchased an alcoholic beverage, one can of Bud Light beer for one dollar and seventy-five cents (\$1.75). The underage operative was not asked for identification.
- 3. The Licensee has held a license under M.G.L. c. 138, § 15 since 1963 with no previous violations.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. As a result, the Commission issues a **WARNING**.
