**DECISION**

**LAVINS, INC. OF WAYLAND  
330 OLD CONNECTICUT PATH

Lavins, Inc. of Wayland ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("ABCC" or "Commission") held a remote hearing via Microsoft Teams on Tuesday, July 30, 2024, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing, the Licensee stipulated to the facts alleged in Investigators Cutter & Teehan's Minimum Purchase Age Compliance Check Field Report.

The following documents are in evidence:

1. Investigators Cutter & Teehan's Minimum Purchase Age Compliance Check Field Report, 3/27/2024;
2. ABCC Form 43, New License Approval, 12/2/1963;
3. Licensee's Stipulation of Facts.

**FINDINGS OF FACT**


1. On Wednesday, March 27, 2024, at approximately 6:39 p.m., Investigators Cutter and Teehan ("Investigators"), conducted a compliance check at Lavins, Inc. of Wayland.
2. An underage operative, working under the supervision of Investigators, purchased an alcoholic beverage, one can of Bud Light beer for one dollar and seventy-five cents (\$1.75). The underage operative was not asked for identification.
3. The Licensee has held a license under M.G.L. c. 138, § 15 since 1963 with no previous violations.

## CONCLUSION


Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. As a result, the Commission issues a **WARNING**.
