Wayland Variety & Deli Corp. d/b/a Vintage Wine (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("Commission" or "ABCC") held a hearing on Tuesday, September 24, 2019, regarding an alleged violation of 204 CMR 2.05 (2)- Permitting an illegality on the licensed premises, to wit: M.G.L. Ch.138 § 34-Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing, the Licensee stipulated to the facts alleged in Investigator Teehan's Report.

- 2. Licensee Stipulation of Fact;
- 3. Copy of Application Approved 4/5/2010.

FACTS

- 1. On Wednesday, July 10, 2019, at approximately 5:10 p.m., Investigators Kenny and Teehan ("Investigators") investigated the business of Wayland Variety & Deli Corp. d/b/a Vintage Wine.
- 2. An underage operative, working with Investigators, purchased from the Licensee an alcoholic beverage, a 12-pack of Budweiser beer. The underage operative was not asked for identification.
- 3. The Licensee has held a license under M.G.L. c. 138, § 15 since 2010 with no prior violations.
