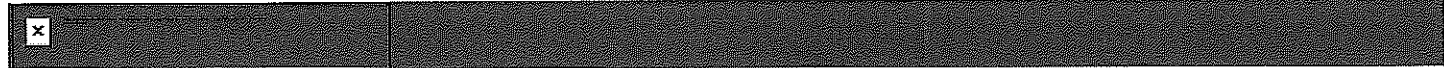

Describe the regulatory issue or observation:: A new auto dealership in Hingham, Herb Chambers of Hingham is on a waiting list for authority/license to be able to annually inspect vehicles. Changes the regulation limiting licenses. Please grant them a license.

Suggestions for improvements to the regulation:: Increase the formula/ maximum capacity of auto dealerships/gas stations that can receive licenses to inspect vehicles. Grant auto dealerships automatic inspection licenses.
