## **DECISION**

JAROSZ PACKAGE STORE INC. D/B/A NIPMUCK LIQUORS 35 THOMPSON ROAD WEBSTER, MA 01570 LICENSE#: 1342-00041

**VIOLATION DATE: 06/26/2017 HEARING DATE: 10/24/2017** 

Jarosz Package Store Inc. d/b/a Nipmuck Liquors (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission (the "Commission" or "ABCC") held a hearing on Tuesday, October 24, 2017, regarding an alleged violation of 204 CMR 2.05 (2) – Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, § 34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing, the Licensee stipulated to the violation alleged in Investigator Keefe's Report.

The following documents are in evidence:

- 1. Investigator Keefe's Compliance Check Field Report; and
- 2. Licensee's Stipulation of Facts.
- A. TIPS Certificate for K. Lepage.

There is one (1) audio recording of this hearing.

The Commission took Administrative Notice of the Licensee's record.

## **FACTS**

- 1. On Monday, June 26, 2017, at approximately 6:12 p.m., Investigators Di Cicco and Keefe ("Investigators") investigated the business operation Jarosz Package Store Inc. d/b/a Nipmuck Liquors.
- 2. An underage operative, working with Investigators, purchased from the Licensee an alcoholic beverage, a can of Coors Light beer for one dollar and forty-seven cents (\$1.47). The underage operative was not asked for identification.

## CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, § 34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Therefore, the Commission suspends the license for a period of three (3) days of which three (3) days will be held in abeyance for a period of two (2) years provided no further violations of Chapter 138 or Commission Regulations occur.
