## **DECISION**

POLISH AMERICAN CITIZENS CLUB, INC. OF WEBSTER MA 37 HARRIS ST.

WEBSTER, MA 01570

This is an appeal of the action of the Town of Webster Board of Selectmen (the "Local Board" or "Webster") for suspending the M.G.L. c. 138, § 12 all alcoholic beverages license of Polish American Citizens Club, Inc. of Webster MA ("Licensee" or "PACC") located at 37 Harris St., Webster, Massachusetts for three (3) days. The Licensee timely appealed the Local Board's decision to the Alcoholic Beverages Control Commission (the "Commission" or "ABCC"), and a hearing was held on Wednesday, August 2, 2017.

On Wednesday, August 2, 2015, an appeal hearing was held as scheduled at 10:00 a.m. The Commission waited until approximately 10:25 a.m. prior to commencing the hearing. The Licensee did not contact the Commission and failed to appear at the hearing. Counsel for Webster requested that the case be dismissed for the Licensee's failure to prosecute. Chairman Lorizio moved that the case be dismissed, and Commissioners McNally and Lashway consented.

## CONCLUSION

The Licensee or an authorized representative failed to appear and pursue this appeal. Therefore, this matter is DISMISSED WITHOUT PREJUDICE FOR FAILURE OF THE APPLICANT TO APPEAR.
