DECISION

CHANDU INC. D/B/A COUNTRY FARM 119 EAST MAIN STREET WEBSTER, MA 01570 LICENSE#: 00043-PK-1342

Chandu Inc. d/b/a Country Farm ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("ABCC" or "Commission") held a remote hearing via Microsoft Teams on Tuesday, August 2, 2022, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing, the Licensee stipulated to the facts alleged in Investigator Temple's Compliance Check Field Report.

- 2. ABCC Form 43 License, Transfer of License Approval, 2/14/2000;
- 3. Licensee's Stipulation of Facts.

At the close of the hearing, the record was left open to Friday, August 5, 2022, for the Licensee to submit an additional exhibit. The Licensee timely submitted its exhibit. The record is now closed.

FINDINGS OF FACT

- 1. On Tuesday, May 24, 2022, at approximately 6:29 p.m., Investigators Terasconi and Temple ("Investigators"), inspected the business operation of Chandu Inc. d/b/a Country Farm.
- 2. An underage operative, working under the supervision of Investigators, purchased a 6 pack of Bud Light beer for \$7.99. The underage operative was not asked for identification.

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Therefore, the Commission issues a **WARNING**.
