Effective November 5, 2008 - from 193 to 249

Effective May 6, 2010 - a new modular unit opened with a rated capacity of 50, changing design/rated capacity from 249 to 299.

² On June 13, 2008 South Middlesex C.C. began housing awaiting trial inmates.

³ Effective Monday February 2, 2009 the DOC added 20 "Community Beds" at Brooke House, contracted with Community Resources for Justice.

⁴Effective April 13, 2009, the security level for the MASAC facility has changed from Medium to Minimum security. In addition to continuing to house 30-day substance abuse civil commitments under MGL Ch.123, s.35, the facility will house inmates serving criminal sentences.

⁵On January 13, 2009, the DOC began the process of double-bunking inmates in some cells at SBCC, with two inmates instead of the previous one inmate per cell.

⁶On June 1, 2009 MCI-Cedar Junction @ Walpole became the reception center, designating one unit as medium security. This unit was designed to hold 72 inmates. All other units will remain at maximum security.
