Massachusetts Department of Public Health COVID-19 Dashboard Nursing Facility Staff Re-Baseline Testing

- On June 30, the Commonwealth issued an evidence-based surveillance testing policy for long-term care facilities to further support the safe care of vulnerable residents in these settings
- Nursing facilities and rest homes are required to comply with the surveillance testing regimen, and may be subject to financial sanctions for non-compliance
- To determine the cadence of surveillance testing, nursing facilities and rest homes were required to perform baseline testing for at least 90% of staff by July 19^{th*}
- This report depicts the percentage of staff tested for COVID-19 at each facility and whether a facility met the 90% threshold. The data is self-attested by nursing facilities and may be subject to further audit and review by EOHHS for final determinations
- The state is supporting surveillance testing costs for nursing facilities and rest homes through September, at which point EOHHS will reassess the testing policy based on public health metrics
- Future versions of this report will include information on adherence to the surveillance testing regimen, based on the results of baseline testing (e.g. facilities with positive staff cases are required to test staff more frequently than facilities with no new cases)

Nursing Facilities Clinical Audits

- On, April 27th the Commonwealth announced a COVID-19 Nursing Facility Accountability and Support Program. The program is predicated on clinical audits every two weeks based on a <u>28-point Infection Control Checklist</u>.
- The 28 point infection control checklist was developed in accordance federal and state guidelines. Audits are completed by licensed nurses and clinical staff trained in infection control.
- The bi-weekly report depicts how each facility has scored on their audits.
- Based on a facility's score on the 28-point checklist, each facility is rated:
 - 1) Green "In Adherence" and scored at least a 24 out of 28
 - 2) Yellow "In Adherence but warrants reinspection" and scored at least 20 out of 28
 - 3) Red "Not in Adherence" and scored under 20 and/or missed at least one of six core competencies
- All facilities have been audited at least twice
- While this is the fourth and final round of audits under the Accountability and Supports program, Massachusetts will continue to regularly survey and audit nursing homes to ensure compliance with infection control and quality standards
