It does not include beds reserved for discipline, investigations, infirmary or other temporary holds for special purposes.

<sup>2</sup>Inmates in general population beds represent inmates housed in units designated to be part of the operational capacity.

<sup>3</sup>The operational occupancy is based on facility occupancy and does not include those housed in support beds.

<sup>4</sup>Inmates in support beds represent inmates housed in units dedicated to housing for special purposes.

<sup>5</sup>The Massachusetts Department of Correction has temporarily suspended the operations of housing units that hold minimum-security and pre-release inmates at MCI-Shirley and South Middlesex Correctional Center.
