DECISION

MAURICE'S CAMPGROUND INC. 80 ROUTE 6 WELLFLEET, MA 02663 LICENSE#: 134800020

HEARING DATE: 11/22/2016

Maurice's Campground Inc. (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, §15. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, November 22, 2016, regarding an alleged violation of 204 CMR 2.05 (2) - Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, §34 - Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing, the Licensee stipulated to the violation alleged in Investigator Binienda's Report.

The following documents are in evidence:

- 1. Investigator Binienda's Compliance Check Field Report dated June 22, 2016; and
- 2. Licensee's Stipulation of Facts.

There is one (1) audio recording of this hearing.

The Commission took Administrative Notice of the Licensee's record.

FACTS

- 1. On Wednesday, June 22, 2016, at approximately 5:30 p.m., Investigators Velez and Binienda ("Investigators") investigated the business operation of Maurice's Campground Inc.
- 2. An underage operative, working with Investigators, purchased from the Licensee an alcoholic beverage, a 12-pack of Budweiser Light beer for fourteen dollar and ninety-nine cents (\$14.99). The underage operative was not asked for identification.

CONCLUSION

Based on the evidence the Commission finds the Licensee violated 204 CMR 2.05 (2) - Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, §34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. As the Licensee has been in business more than 30 years with no prior violations, the Commission issues a **WARNING**.
