DECISION

MJT ENTERPRISES INC. D/B/A BLACKFISH VARIETY

MJT Enterprises Inc. d/b/a Blackfish Variety ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("ABCC" or "Commission") held a remote hearing via Microsoft Teams on Tuesday, November 28, 2023, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing the Licensee stipulated to the facts alleged in Investigators Velez and Binienda's Minimum Purchase Age Compliance Check Field Report.

The following documents are in evidence:

1. Investigators Velez and Binienda's Minimum Purchase Age Compliance Check Field Report, 6/21/2023;
2. ABCC Form 43, New License Approval, 5/9/2012;
3. Licensee's Stipulation of Facts.

FINDINGS OF FACT


1. On Wednesday, June 21, 2023, at approximately 5:18 p.m., Investigators Binienda and Velez ("Investigators") conducted a compliance check at MJT Enterprises Inc. d/b/a Blackfish Variety.
2. An underage operative, working under the supervision of Investigators, purchased an alcoholic beverage, one 24-ounce White Claw Black Cherry Hard Seltzer, for three dollars and fifty-nine cents (\$3.59). The underage operative was not asked for identification.
3. The Licensee has held a license under M.G.L. c. 138, § 15 since 2012 with no prior violations.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. As a result, the Commission issues a **WARNING**.
