PEER COMMUNITY COMPARISON

The Division of Local Services (DLS) Technical Assistance Bureau compiled a peer community comparison at the request of the Town of West Boylston. To do so, DLS analyzed an extensive dataset using the <u>DLS databank</u> that included financial, property tax-related, and socioeconomic attributes on all 351 communities in the Commonwealth. We then defined a standard from which our peer models were formed by analyzing municipalities whose proximity, population, and other factors corresponded in a meaningful way to West Boylston. Selected "peer" communities had to be within +/- 10 percent of the metric being ranked against West Boylston. We did not weigh certain data, such as department spending levels, as part of our evaluation because it did not universally correlate across communities. We encourage local officials to review the final peer comparison presented here and apply whatever additional analyses or other qualitative traits they feel most similarly match West Boylston.

Model 1: Worcester County – Our first data model includes all 60 communities in Worcester County. Even though the town requested an emphasis on Worcester County, all but three communities in this data model can be unilaterally excluded because, other than boundary lines, there are few nonbudgetary characteristics in common with West Boylston. Douglas and Lancaster qualify for consideration based upon population, location, and per capita income. Sterling could also be included based on population and location.

Model 2: Bordering Communities Model – Our second data model focuses on those communities that share a common border with West Boylston, including Sterling, Holden, Boylston, Worcester, and Shrewsbury. Except for Sterling, the list of adjacent towns does not yield any meaningful results beyond their shared boundary, as these communities vary widely in structure, size, and income levels.

Peer Model #2: Neighboring/Bordering Communities

This peer model set includes all 5 communities sharing geographical borders with West Boylston

Model 3: Comparative Peer Model – Our third model applies filters ranking population, per capita income, and equalized valuation per capita to extract communities that were between 90 and 110 percent of West Boylston's value for each metric. Although several communities share common data points, such as population, we removed municipalities whose particular characteristics yielded disparate and incomparable results including mid-tier cities and more densely populated urban areas. Next, we ranked communities with similar service levels and ability to pay. After narrowing the focus and considering other common characteristics, we developed a final set of ten comparative peer communities as shown below.

Peer Model #3: Comparative Peer Models

This peer model set includes 10 communities located across the Commonwealth who share relatively similar financial characteristics as West Boylston.

We believe Halifax, Dighton, and Douglas are most closely aligned to West Boylston. Halifax resembles West Boylston based on population, income per capita, equalized valuation per capita, and average single-family tax bill per capita. While not a core standard, they are also within +/- 10 percent of total expenditures per capita. Dighton also shares many of the same characteristics as West Boylston, including income per capita, equalized valuation per capita, and percent of the tax levy borne by the residential parcel class. We encourage the town to explore the organizational structures and the types of services offered in these peer communities to ensure they are a good overall fit for comparative analyses.
