DECISION

SAJA ENTERPRISE, INC. D/B/A MOTION GAS AND PROPANE 710 NORTH MAIN STREET WEST BRIDGEWATER, MA 02379

Saja Enterprise, Inc. d/b/a Motion Gas and Propane ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("ABCC" or "Commission") held a remote hearing via Microsoft Teams on Tuesday, November 14, 2023, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing the Licensee stipulated to the facts alleged in Investigators Watson and Smith's Minimum Purchase Age Compliance Check Field Report.

The following documents are in evidence:

- 1. Investigators Watson and Smith's Minimum Purchase Age Compliance Check Field Report, 6/21/2023;
- 2. Licensee's Stipulation of Facts;
- 3. ABCC Form 43, Transfer of License Approval, 5/11/2016.

FINDINGS OF FACT

- 1. On Wednesday, June 21, 2023, at approximately 5:20 p.m., Investigators Watson and Smith ("Investigators") conducted a compliance check at Saja Enterprise, Inc. d/b/a Motion Gas and Propane.
- 2. An underage operative, working under the supervision of Investigators, purchased an alcoholic beverage, one six-pack of Bud Light beer, for six dollars (\$6.00). The underage operative was not asked for identification.
- 3. The Licensee has held a license under M.G.L. c. 138, § 15 since 2016.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. As a result, the Commission issues a **WARNING.**
