FUEL FIRST ELM OP INC. D/B/A SPARKY'S 173 ELM STREET WEST SPRINGFIELD, MA 01089 LICENSE#: 1418-00069

Fuel First Elm Op Inc. d/b/a Sparky's (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, August 1, 2017, regarding an alleged violation of 204 CMR 2.05 (2) — Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, § 34 — Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing, the Licensee stipulated to the violation alleged in Investigator Di Cicco's Report.

The following documents are in evidence:

- 1. Investigator Di Cicco's Compliance Check Field Report; and
- 2. Licensee's Stipulation of Facts.

There is one (1) audio recording of this hearing.

The Commission took Administrative Notice of the Licensee's record.

FACTS

- 1. On Monday, May 22, 2017, at approximately 5:49 p.m., Investigators Kujawski and Di Cicco ("Investigators") investigated the business operation of Fuel First Elm Op Inc. d/b/a Sparky's.
- 2. An underage operative, working with Investigators, purchased from the Licensee an alcoholic beverage, a 16-ounce bottle Bud Light beer, for one dollar and ninety-nine cents (\$1.99). The underage operative was not asked for identification.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, § 34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Therefore, the Commission suspends the license for a period of three (3) days of which three (3) days will be held in abeyance for a period of two (2) years provided no further violations of Chapter 138 or Commission Regulations occur.
