DECISION

FUEL FIRST ELM OP INC. D/B/A SPARKY'S 173 ELM STREET WEST SPRINGFIELD, MA 01089

Fuel First Elm Op Inc. d/b/a Sparky's ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("ABCC" or "Commission") held a remote hearing via Microsoft Teams on Tuesday, November 7, 2023, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing the Licensee stipulated to the facts alleged in Investigators Gould and Kujawski's Minimum Purchase Age Compliance Check Field Report.

- 2. ABCC Form 43, New License Approval, 12/22/2015;

FINDINGS OF FACT

- On Wednesday, May 3, 2023, at approximately 5:35 p.m., Investigators Gould and Kujawski ("Investigators") conducted a compliance check at Fuel First Elm Op Inc. d/b/a Sparky's.
- 2. An underage operative, working under the supervision of Investigators, purchased an alcoholic beverage, a 25-ounce can of Bud Light beer for four dollars (\$4.00). The underage operative was not asked for identification.
- 3. The Licensee has held a license under M.G.L. c. 138, § 15 since 2015 with one prior violation which occurred over five (5) years ago.

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Therefore, the Commission issues a **WARNING.**
