JAI VEER CORP D/B/A SUNNYS CONVENIENCE 2240-2260 WESTFIELD STREET WEST SPRINGFIELD, MA 01089

Jai Veer Corp d/b/a Sunnys Convenience ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("ABCC" or "Commission") held a remote hearing via Microsoft Teams on Tuesday, October 10, 2023, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing the Licensee stipulated to the facts alleged in Investigators Kujawski and Gould's Minimum Purchase Age Compliance Check Field Report.

The following documents are in evidence:

- 1. Investigators Kujawski and Gould's Minimum Purchase Age Compliance Check Field Report, 5/3/2023;
- 2. ABCC Licensing Authority Certification, Transfer of License Approved 10/26/2020;
- 3. Licensee's Stipulation of Facts.

FINDINGS OF FACT

- 1. On Wednesday, May 3, 2023, at approximately 7:11 p.m., Investigators Gould and Kujawski ("Investigators") conducted a compliance check at Jai Veer Corp d/b/a Sunnys Convenience.
- 2. An underage operative, working under the supervision of Investigators, purchased an alcoholic beverage, a 16-ounce Bud Light beer for two dollars (\$2.00). The underage operative was not asked for identification.
- 3. Neil Patel and Kush PateL appeared on behalf of the Licensee at the Commission hearing.
- 4. The Licensee has held a license under M.G.L. c. 138, § 15 since 2020 with no prior violations.

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. As a result, the Commission issues a **WARNING**.
