Feng Ye Inc. ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 12. The Alcoholic Beverages Control Commission ("Commission" or "ABCC") held a hearing on Tuesday, June 17, 2025, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing the Licensee stipulated to the facts alleged in Investigators Fleming & Keefe's Minimum Purchase Age Compliance Check Field Report.

The following documents are in evidence:

- 1. Investigators Fleming & Keefe's Minimum Purchase Age Compliance Check Field Report, 3/31/2025;
- 2. ABCC Licensing Authority Certification, New License Approved 9/12/2023;

FINDINGS OF FACT

- 1. On Monday, March 31, 2025, at approximately 6:33 p.m., Investigators Fleming & Keefe ("Investigators") conducted a compliance check at Feng Ye Inc.
- 2. An underage operative, working under the supervision of Investigators, purchased an alcoholic beverage, one 12-ounce bottle of Corona beer for six dollars and sixty-one cents (\$6.61). The underage operative was not asked for identification.
- 3. The Licensee has held a license under M.G.L. c. 138, § 12 since 2023.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. As a result, the Commission issues a WARNING.
