

FINAL DECISION

I have reviewed the attached Settlement Agreement and Administrative Consent Orders and Notices of Noncompliance signed on December 18, 2020 by William Hull, Manager of Westfield Paper Lands, LLC and General Partner of Hull Forestlands, LP, and on December 23, 2020 by Kellie Niemiec on behalf of Michael Gorski, Regional Director for the Department (ACOP #00010013 and ACO# 00010292).

The Department issues this Final Decision incorporating the two Administrative Consent Orders (ACOP #00010013 and ACO# 00010292). The petitioner is ordered to pay a civil administrative penalty of seventeen thousand five hundred dollars (\$17,500) in accordance with the schedule set forth in paragraphs 15 and 23 of the Administrative Consent Orders. Under the terms of 310 CMR 1.01(8)(c), these proceedings are dismissed with the parties waiving whatever rights they may have to further administrative review before the Department as well as any appeal to court.
