DECISION

SHREE GANESH CORPORATION DBA WESTFORD MARKET & LIQUORS 6 CARLISLE PLACE UNIT 8 WESTFORD, MA 01886 LICENSE#: 144200042

Shree Ganesh Corporation dba Westford Market & Liquors (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, §15. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, June 10, 2014, regarding an alleged violation of 204 CMR 2.05 (2) – Permitting an illegality on the licensed premises, to wit: c. 138, §34 Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing, the licensee stipulated to the violation alleged in Investigator Bailey's Report.

The following documents are in evidence:

1. Licensee's Stipulation of Facts; and

2. Investigator Bailey's Investigative Report dated March 12, 2014.

There is one (1) audio recording of this hearing.

FACTS

- 1. On Wednesday, March 12, 2014 at approximately 6:06 p.m., Investigators Doyle and Bailey conducted an investigation of the business operation of Shree Ganesh Corporation dba Westford Market & Liquors.
- 2. An underage operative, working with investigators, purchased an alcoholic beverage, a twenty five ounce (25 oz.) Budweiser Light beer for two dollars and fifty cents (\$2.50). The underage operative was not asked for identification.

CONCLUSION

Based on the evidence, the Commission finds the licensee violated 204 CMR 2.05 (2) – Permitting an illegality on the licensed premises, to wit: c. 138, §34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. As the licensee has been in business for more than ten (10) years and has had no previous violations, the Commission issues a **WARNING**.
