FINAL DECISION

I adopt the Recommended Final Decision of the Presiding Officer. As such, I affirm the Draft Waterways License, dated October 26, 2021, issued by the Southeast Regional Office of the Massachusetts Department of Environmental Protection in this case, with one additional special condition. The additional special condition shall preserve existing public rights to access the solid fill jetty to avoid substantial interference with the ability to pass freely upon the waterways and to engage in transport or loading/unloading activities, as described in the Recommended Final Decision.

The parties to this proceeding are notified of their right to file a motion for reconsideration of this decision, pursuant to 310 CMR 1.01(14)(d). The motion must be filed with the Case Administrator and served on all parties within seven business days of the postmark date of this decision. A person who has the right to seek judicial review may appeal this decision

to the Superior Court pursuant to M.G.L. c. 30A, §14(1). The complaint must be filed in the Court within thirty days of receipt of this decision.
