#### **DECISION**

LINCOLN SQUARE SERVICE INC. D/B/A LINCOLN SQUARE SERVICE 185 WASHINGTON STREET WEYMOUTH, MA 02188

Lincoln Square Service Inc. d/b/a Lincoln Square Service ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("ABCC" or "Commission") held a remote hearing via Microsoft Teams on Tuesday, November 7, 2023, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing, the Licensee stipulated to the facts alleged in Investigators Gardner and Terasconi's Minimum Purchase Age Compliance Check Field Report.

The following documents are in evidence:

- 1. Investigators Gardner and Terasconi's Minimum Purchase Age Compliance Check Field Report, 6/6/2023;
- 2. ABCC Form 43, New License Approval, 11/19/2013;
- 3. Licensee Stipulation of Facts.

There is one (1) audio recording of this hearing.

#### FINDINGS OF FACT

- 1. On Tuesday, June 6, 2023, at approximately 7:12 p.m., Investigators Terasconi and Gardner ("Investigators") conducted a compliance check at Lincoln Square Service Inc. d/b/a Lincoln Square Service.
- 2. An underage operative, working under the supervision of Investigators, purchased an alcoholic beverage, one 24-ounce can of White Claw Hard Seltzer, for three dollars and seventy-five cents (\$3.75). The underage operative was not asked for identification.
- 3. Ramez Metri, License Manager, appeared at the Commission hearing and testified the Licensee has since upgraded their point-of-sale system and now requires employees to scan a patron's identification prior to being allowed to process a sale of alcoholic beverages.

4. The Licensee has held a license under M.G.L. c. 138, § 15 since 2013 with no prior violations.

### CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Therefore, the Commission issues a **WARNING.**
