## **DECISION**

STELLENNY LIQUORS INC. D/B/A MICHAEL'S WINE & SPIRITS 461 WASHINGTON ST. WEYMOUTH, MA 02189

LICENSE#: 1458-00060

**VIOLATION DATE: 05/30/2017 HEARING DATE: 08/15/2017** 

Stellenny Liquors Inc. d/b/a Michael's Wine & Spirits (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, August 15, 2017, regarding an alleged violation of 204 CMR 2.05 (2) — Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, § 34 — Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing, the Licensee stipulated to the violation alleged in Investigator Temple's Report.

The following documents are in evidence:

- 1. Investigator Temple's Compliance Check Field Report; and
- 2. Licensee's Stipulation of Facts.

There is one (1) audio recording of this hearing.

The Commission took Administrative Notice of the Licensee's record.

## **FACTS**

- 1. On Tuesday, May 30, 2017, at approximately 7:55 p.m., Investigators Temple and Di Cicco ("Investigators") investigated the business operation of Stellenny Liquors Inc. d/b/a Michael's Wine & Spirits.
- 2. An underage operative, working with Investigators, purchased from the Licensee an alcoholic beverage, a 25-ounce container of Bud Light beer, for three dollars (\$3.00). The underage operative was not asked for identification.

## **CONCLUSION**

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, § 34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. As the Licensee has been in business for more than 10 years with no prior violations, the Commission issues a **WARNING**.
