## DECISION

JAI MARUTI LLC D/B/A WHITMAN CONVENIENCE STORE **183 SOUTH AVENUE** WHITMAN, MA 02382 LICENSE#: 146200034

Jai Maruti LLC d/b/a Whitman Convenience Store (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, §15. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, May 31, 2016, regarding an alleged violation of 204 CMR 2.05 (2) - Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, §34 -Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing, the Licensee stipulated to the violation alleged in Investigator Carey's Report.

The following documents are in evidence:

- 1. Investigator Carey's Compliance Check Field Report dated March 28, 2016; and
- 2. Licensee's Stipulation of Facts.

There is one (1) audio recording of this hearing.

The Commission took Administrative Notice of the Licensee's record.

## <u>FACTS</u>

- 1. On Monday, March 28, 2016, at approximately 5:59 p.m., Investigator Carey investigated the business operation of Jai Maruti LLC d/b/a Whitman Convenience Store.
- 2. An underage operative, working with Investigators, purchased from the Licensee an alcoholic beverage, a 12 oz. bottle of Budweiser Light beer, for one dollar and forty-nine cents (\$1.49). The underage operative was not asked for identification.

## CONCLUSION

Based on the evidence the Commission finds the Licensee violated 204 CMR 2.05 (2) -Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, §34 - Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Commission suspends the license for three (3) days of which three (3) days will be held in Therefore, the abeyance for a period of two (2) years provided no further violations of Chapter 138 or Commission Regulations occur.
