Subject: **WIA Youth Performance Training**

Purpose: To notify Local Workforce Investment Boards, One-Stop Career Center Operators and local workforce investment partners of five (5), ½ day training sessions around WIA Youth Performance, scheduled for dates in April and May 2009.
