Bellasophia LLC dba Dana's Grillroom (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, §12. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, June 24, 2014, regarding an alleged violation of 204 CMR 2.05 (2) – Permitting an illegality on the licensed premises, to wit: c. 138, §34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing, the licensee stipulated to the violation alleged in Investigator Keefe's Report.

The following documents are in evidence:

- 1. Investigator Keefe's Investigative Report dated February 26, 2014;
- 2. Licensee's Stipulation of Facts;
- 3. Notice of Violation dated 2/26/2014; and
- 4. Picture of underage individual.

FACTS

- 1. On Wednesday, February 26, 2014 at approximately 7:07 p.m., Investigators Kujawski and Keefe conducted an investigation of the business operation of Bellasophia LLC dba Dana's Grillroom.
- 2. An underage operative, working with investigators, purchased a bottle of Budweiser Light beer for three dollars and fifty cents (\$3.50). The underage operative was not asked for identification.

CONCLUSION

Based on the evidence, the Commission finds the licensee violated 204 CMR 2.05 (2) – Permitting an illegality on the licensed premises, to wit: c. 138, §34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Therefore, the Commission suspends the license for three (3) days of which three (3) days will be held in abeyance for a period of two (2) years provided no further violations of Chapter 138 or Commission Regulations occur.
